DEED OF VARIATION NO. 1

Parties

This Deed of Variation is made between and binds the following parties:

COMMONWEALTH OF AUSTRALIA (the Commonwealth) represented by and acting through the Department of Families, Housing, Community Services and Indigenous Affairs ABN 36 342 015 855 (the Department)

AND

COLMAR BRUNTON PTY LIMITED

ABN 22 003 748 981, ACN 003 748 981 an Australian Proprietary Company (the Service Provider)

Context

This Deed of Variation is made in the following context:

- A. The Department and the Contractor entered into a Deed of Agreement for the provision of Contract Services in relation to communications-related market research as a member of the Communication Market Research Panel and dated 15 May 2008 (the Principal Contract).
- B. The parties agree to vary the Principal Deed of Agreement in the manner specified in this Deed of Variation.

Operative Provisions

The parties to this Deed of Variation agree to vary the Principal Contract as follows:

1. Replace clause **2. Term of Agreement** with the following:

2.1 This Deed commences on 19 May 2008 and continues in force for a period of three (3) years unless sooner determined.

2.2 The Department has the option to extend the period of this Deed by two twelve (12) month extensions, allowable by giving the Contractor written notice of such extension prior to the expiration of the initial three (3) year period. Any such extension will be on the same terms and conditions with the exception of this provision.

2.3 The Department and Contractor will exercise the first of the two twelve (12) month extension options.

2. This parties agree that this variation has effect as a Deed.
