Overall:

All three pools have now been installed and are operational. Brewarrina Shire Council has agreed to pay their pool operator to oversee the management of the pools and to train the community to run the pools to public pool standard. The pools are in Winter hiatus until the long weekend in October.

1. Admission fee collected as a percentage of fee charged

As the pool has not opened yet no fees have been collected.

2. Description of community awareness of the facility

s47G - business interest is still high and a recent community meeting established that the community was still committed to managing the facility once it was built. Two young men have agreed to be the pool managers and others have indicated once the pool is operating that they will undertake their bronze medallion in Lifesaving

3. Description of facilities provided with this funding

Facilities now include three pools – one wading pool and one 12m pool and one 10m (for aquarobics) as ground structure will not sustain a 20m fibreglass pool (please see photos attached). There are two separate filtration plants – one for the wading pool and one for the other two pools – pool systems are automated with automatic chlorination and pH balancing. Part of the facility is also a rinsing shower with modesty screen and several picnic tables. The facility is surrounded by a 6ft high mesh fence topped with barbed wire to prevent unauthorised entry. The pool also has lighting so that pool can be used in the evening if needed.

4. Description of initiatives/activities undertaken to improve asset management arrangements including implementation of management plan

As indicated above, the community has been heavily engaged in training themselves to both manage the pool and ensure the safety of those who manage the pool. Discussions have been held with the community regarding management of the pool and the community has asked that the CDEP provider be engaged to include pool management as an activity which the CDEP provider has agreed to. The community has also established an Aboriginal Corporation to manage the pool and as explained above the Shire's pool operator will also oversee the management of the pool.
