As outlined in a previous response, [REDACTED] was one of four Townsville based indigenous organisations investigated in 2008 by FaHCSIA's Indigenous Programs Investigation Branch. [REDACTED]

The investigation determined that there were no criminal or civil matters relating to FaHCSIA funding that would warrant further investigation by FaHCSIA.

The Australian Government has strict measures in place to ensure funding accountability and has the ability to take action if there is alleged impropriety.

Organisations funded by the Australian Government are issued with performance-based and legally enforceable funding agreements which set out the terms and conditions governing a business relationship.

FaHCSIA also has a complaints management process whereby any member of the public can lodge a concern about a FaHCSIA funded service providers, including the reporting of suspected fraud.

If the service provider is not funded by FaHCSIA, the complainant would be referred to the appropriate Department/Agency for action.

Charity begins at home Indigenous funds row deepens

A COMPANY set up as a charity for indigenous housing is providing homes for members of its board and their family. Public records show a Kirwan home owned by the ABIS Community Co-operative Society is occupied by one of its directors, Angie Akee.

Ms Akee's sister Agnes Tapim is the chairwoman of the society, which receives generous tax breaks through its registration as a charitable institution. Homes occupied by another of Ms Akee's sisters, Sandra Santo, and another director, Mamam Martin, are also owned by ABIS.

Names of the ABIS directors were obtained from the Office of Fair Trading, their addresses through the electoral roll and the property ownership through an online database. Among the directors named in the Fair Trading records are two women, believed to be Ms Akee's aunts, one of her Townsville Aboriginal and Islanders Health Services workmates and one deceased man who is listed twice as a director. Ms Akee's involvement with a number of indigenous organisations was questioned in a special report in Saturday's Townsville Bulletin. She is in a \$120,000-a-year paid position with TAIHS.

Her sister, Ms Santo, is a director on the TAIHS board. Yesterday, Ms Akee did not want to answer or even hear the claims, saying she did not need to defend herself as she had done nothing wrong.

"I'm not prepared to make any more statements about me," she said. "These people running off to (Herbert MP Ewen) Jones you need to question them about their actions.

"What are they doing about homelessness in our community, deaths in custody and the health and education of our people?"

Townsville City Council community safety committee chairman Dale Last, who has been working on possible solutions for homelessness in the city, said the revelations were disappointing.

"You would like to think that all the relevant government organisations and authorities set up to deal with these issues are generally working towards providing accommodation," he said. "It disappoints me to hear stories such as this when there are so many people working so hard to solve these particular problems.

"There's an extraordinary amount of money that gets spent on these particular issues in this city and we really have to question whether there is any headway being made in terms of addressing these problems, and situations such as this certainly don't help."

Speaking about co-operative societies in general, local lawyer Evan Sarinas said providing private benefits clashed with societies' registration as a charitable institution.

"It is incongruous for a charity's objects to provide for private benefits," he said.

Australian Government records show that ABIS is exempt from income tax, receives a rebate on Fringe Benefits Tax and a concession on GST.

An Australian Taxation Office spokesman yesterday said the status of charitable entities could be reviewed, with their status revoked and tax concessions repaid if necessary.

"Where an entity is no longer considered to be charitable it is no longer entitled to charitable tax concessions and standard business taxes would apply," he said.

"This action could also be retrospective where an entity is found to have not been a charity for a period of time.

"The ATO grants charitable status . . . and certain elements, such as being not-for-profit and not making distributions to members must be clearly included.

"If the organisations is incorporated it may be subject to further legal activity for acting contrary to the terms of its incorporation which may take place at the state or territory level."

Money 'goes missing' Aboriginal funds probe

TWO Townsville indigenous organisations have come under scrutiny, with one ordered to fix 18 breaches and another under investigation for hundreds of thousands of dollars in missing funds.

Both have directors from the same family accused earlier this month of nepotism and

mismanagement in the Townsville Aboriginal and Islanders Health Services and ABIS Community Co-operative Society.

The family has denied the claims, which were referred to the Crime and Misconduct Commission last week.

A compulsory examination of the Queensland Health-funded Twin Cities Aboriginal and Torres Strait Islanders Corporation (Aged Care) was carried out by the Office of the Registrar of Indigenous Corporations last month.

It came after two consecutive audits found hundreds of thousands of dollars had not been accounted for.

According to public financial statements for 2007-08, more than \$72,000 in spending was unaccounted for, and more than \$50,000 had been moved to wage accounts but never put through the payroll system. The 2008-09 statements found more than \$145,000 could not be accounted for.

For both years, the auditors found funds had been removed via cheques made out to cash in amounts between \$1000 and \$5000, apart from one mystery cheque for more than \$29,000 in 2007.

The result of the examination is likely to be published next week.

After an examination in 2008, the indigenous corporations registrar issued the Townsville Aboriginal and Torres Strait Islander Corporation for Women a compliance notice, outlining 18 breaches including an improperly maintained member list.

The women's corporation is funded by Disability Services Queensland, the federal Department of Health and Ageing and the federal Department of Families, Housing, Community Services and Indigenous Affairs to provide Home and Community Care Services to indigenous elders and people with disabilities. The registrar's office found annual general meetings were not being held according to the corporation's rules, minutes were not being kept, a director had been appointed without first being a member of the organisation and there was no record of them being properly elected.

Aboriginal health services' director of operational services Angie Akee along with six close relatives is named as a director of the women's corporation, and documents show that 24 of the organisation's 29 registered members are also family members.

The organisation wrote to clients in March, saying services would be cut because of funding restraints from the extra workload caused by Cyclone Yasi.

State Government intervenes CMC to probe Akee family

THE Crime and Misconduct Commission will investigate serious claims of nepotism, rorting and board-stacking at the highest levels of Townsville's top indigenous organisations.

Townsville MP Mandy Johnstone, pictured, yesterday referred claims of mismanagement and nepotism to the commission, saying it was the only body properly equipped to "get to the bottom of this". The development came as Herbert MP Ewen Jones told Federal Parliament that administrators must be appointed to investigate the long-held suspicions of rorting and board stacking.

At the centre of the claims is Townsville Aboriginal and Islanders Health Services director of operational services Angie Akee, along with her direct and extended family, who hold controlling positions in up to nine indigenous organisations. Ms Akee has strongly denied the claims.

Among the organisations in question is the ABIS Community Co-operative Society, an indigenous housing body of which Ms Akee is a director.

The Bulletin revealed she, and two other directors, each occupy homes owned by the company which is registered as a charity.

Since publishing the initial claims on Saturday, the Townsville Bulletin has been contacted by many more people who claim to have knowledge of inappropriate behaviour by the family.

Ms Johnstone, who was reluctant to speak directly about TAIHS earlier this week,

yesterday took the claims to the CMC and called for an investigation to finalise them, one way or another.

"This is about mothers, babies and their families. It's about their safety, their health and hope for their future," she said.

"In the interests of all involved, I have forwarded these serious allegations to the CMC for their immediate attention.

"Over the years, (TAIHS) has been an absolutely wonderful organisation so we need to put these matters to rest either way and let the CMC do their job."

In Federal Parliament, Mr Jones said he had been "besieged" by people demanding action on the long-running suspicions.

"I have received reports of nepotism, bullying, robbing of funding and allowances, and board stacking across the Aboriginal and Islander bodies in Townsville," he said.

"I have come to the conclusion that this government is totally aware of what is going on in this organisation and others where this family has influence and has deliberately chosen to do nothing.

"They already know that these organisations are rife with questionable corporate governance and lack financial accountability.

"The Government simply lacks the political will to address this major concern."

Mr Jones told parliament the Government did "not care about the overall health of our first Australians, or that the funds meant for their well-being are being misused".

"This government and Minister Macklin stand condemned by their lack of action here," he said.

"It has taken a group of Aboriginals and Islanders to stand up and fight for what is right. These people have the courage to stand up against the might of this government and the financial muscle of this organisation. Despite knowing this government does not care, they still come forward with their stories in the hope that something will be done."

Mr Jones said administrators should be immediately appointed.

"If this government is serious about accountability, it will instigate a forensic audit of this organisation and all organisations influenced by this family," he said. kathleen.skene@townsvillebulletin.com.au

I would like to make a time to speak to Ms Macklin at her earliest convenience about serious and long-running claims of mismanagement in some of Townsville's Indigenous organisations.

By way of background, the organisations involved all share board members and directors, who are composed largely of members of one local family.

Former Federal Member for Herbert Peter Lindsay mentioned this issue before the House of Representatives on June 24, 2008 <http://www.aph.gov.au/hansard/rep/dailys/dr240608.pdf> and wrote to Ms Macklin the following day requesting an open and detailed inquiry into the administration of four Townsville-based organisations. Current MP for Herbert Ewen Jones claims the office never received a reply to this letter or the parliamentary mention.

There have been numerous claims from the community, including former doctors and other staff of these organisations, of bullying and the misappropriation of funds and resources, which, they claim, have led to reduced services for the significant and disadvantaged Aboriginal and Islander community in North Queensland.

I would appreciate the opportunity to discuss this important issue with Ms Macklin soon.


