National Rental Affordability Scheme Tenant Demographic Report

The National Rental Affordability Scheme (NRAS) is an Australian Government initiative, in partnership with the states and territories, to stimulate the supply of new affordable rental dwellings.

Approved participants of the Scheme are eligible to receive a national rental incentive for each approved dwelling where it is rented to eligible low and moderate income households at a rate that is at least 20 per cent below the prevailing market rates.

Approved participants provide tenant data throughout the year to assist the Department of Social Services (the Department) to satisfy the compliance requirements prescribed by the Scheme's regulations and to better understand the demographic features of tenants living in NRAS dwellings.

The data published in this report was obtained by approved participants from tenants of NRAS dwellings, reported as tenanted as at 30 April 2025. The report excludes vacant dwellings. Some questions asked of tenants within this report are optional, with mandatory questions denoted throughout the report.

Tenant Demographic Data Breakdown as at 30 April 2025

All tenant demographic data included in this report is a point in time snapshot as at 30 April 2025. The information provided in the below tables is sourced from the tenant consent form required to be lodged for occupied dwellings in the NRAS program.

Key points (as at 30 April 2025):

- Total number of NRAS tenants accommodated in the Scheme was **22,021** for a total of **13,158** dwellings. A breakdown of these tenants by state and territory is shown in Table 1 and by age in Table 2.
- The Household composition figures in Table 3 include mandatory responses for tenants identifying as either Sole Parents or Independent Minors. These demographics made up **2,834** of the total **38,042** responses received.
Note: tenants could identify in more than one category.
- An ‘*’ within the tables below denotes a mandatory response. All other responses are voluntary.
